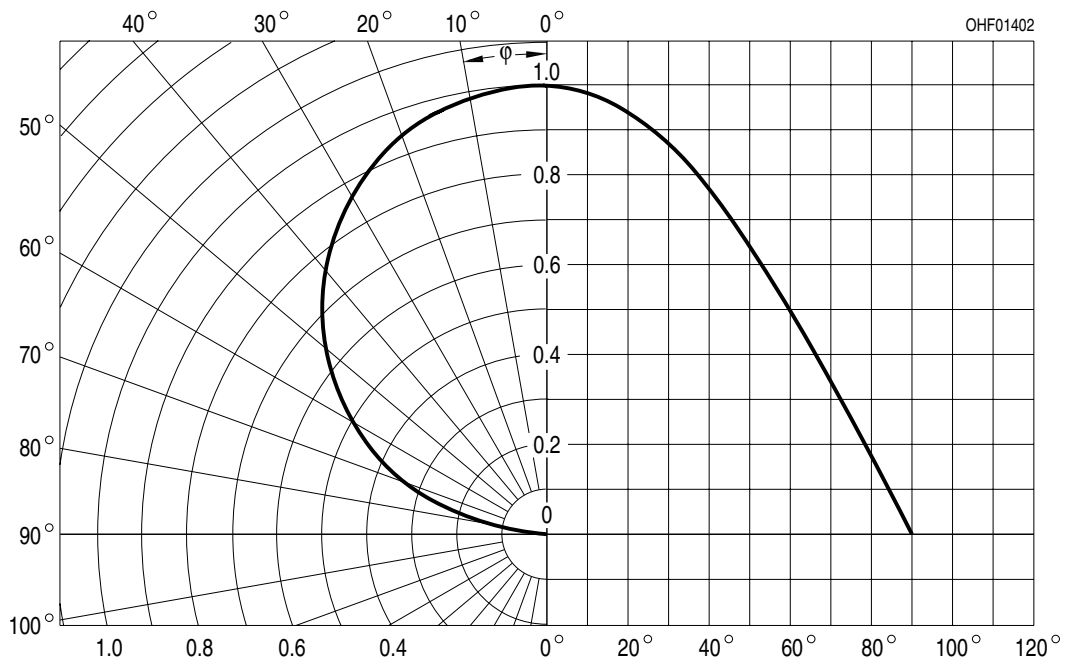

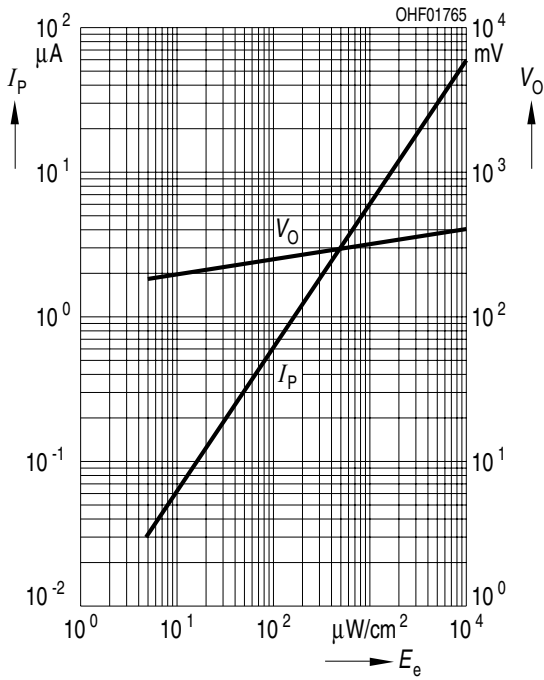
Directional Characteristics ^{2), 3)}

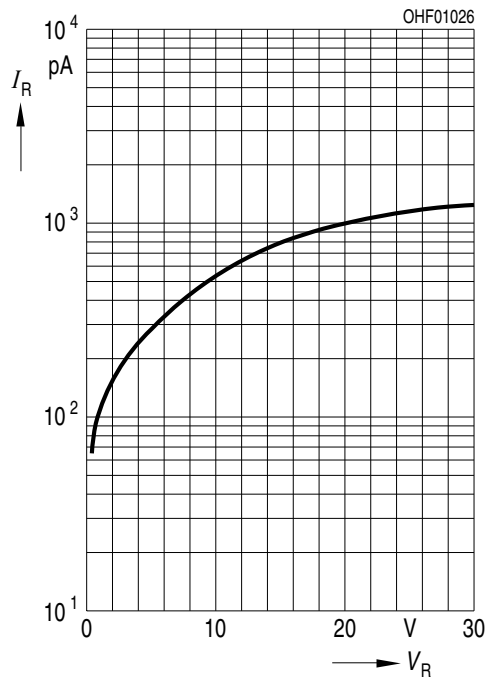

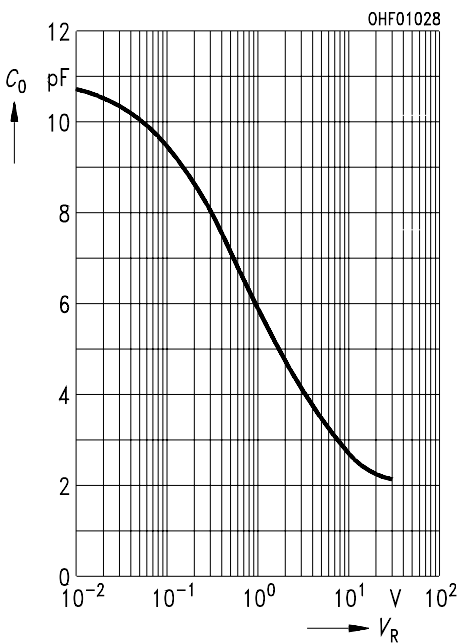

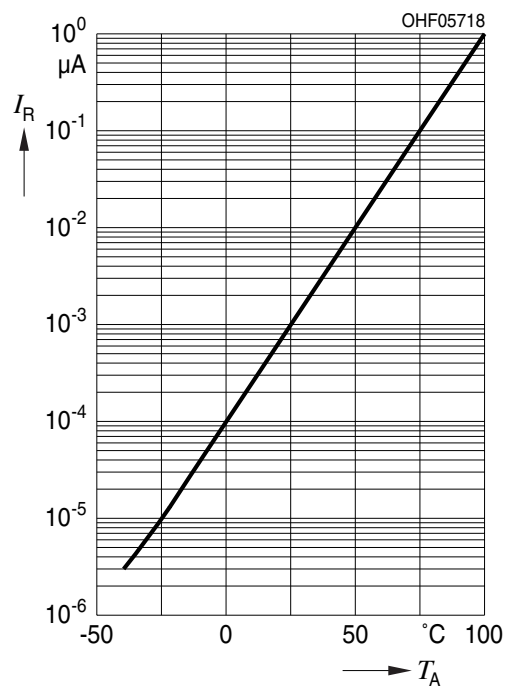

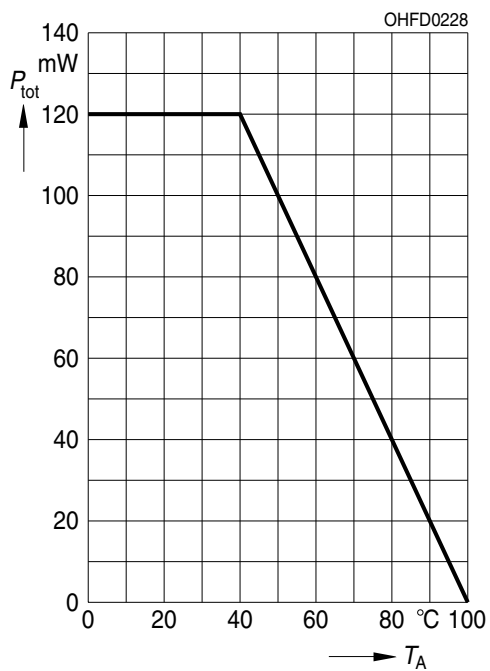

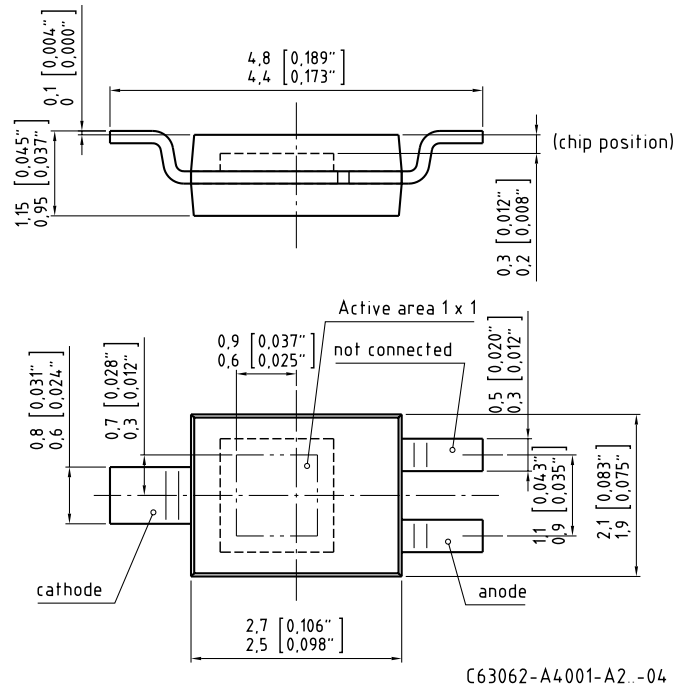


Power Consumption

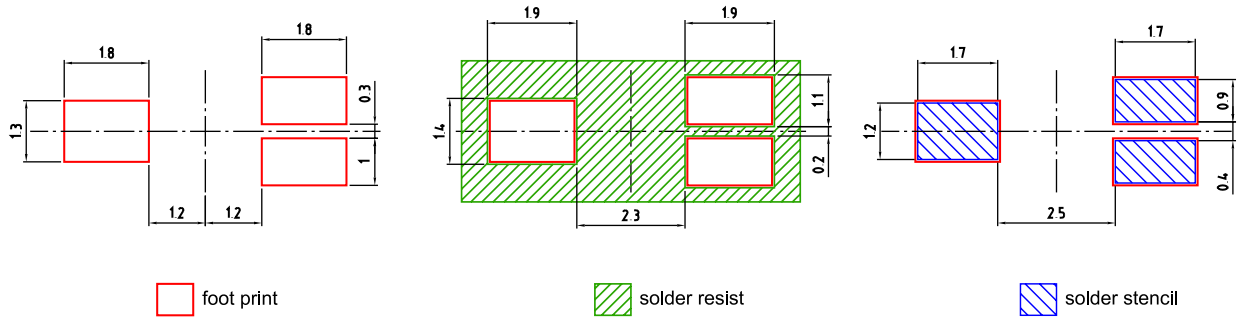

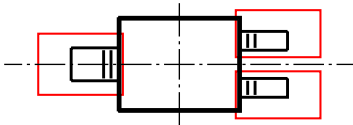

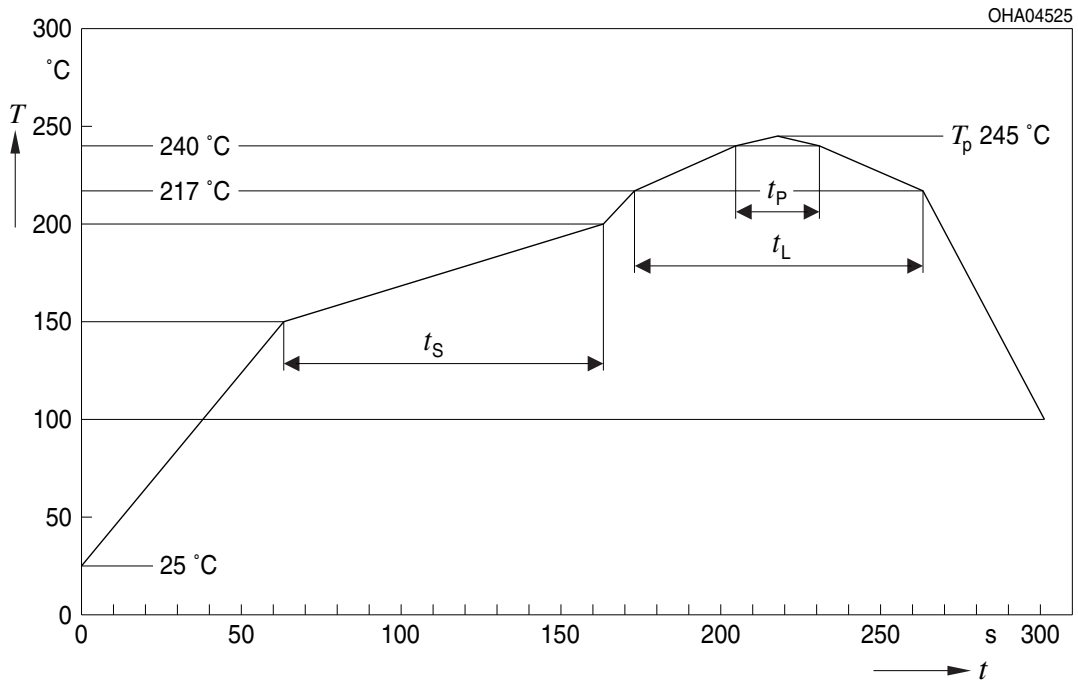
Component Location on Pad

Reflow Soldering Profile

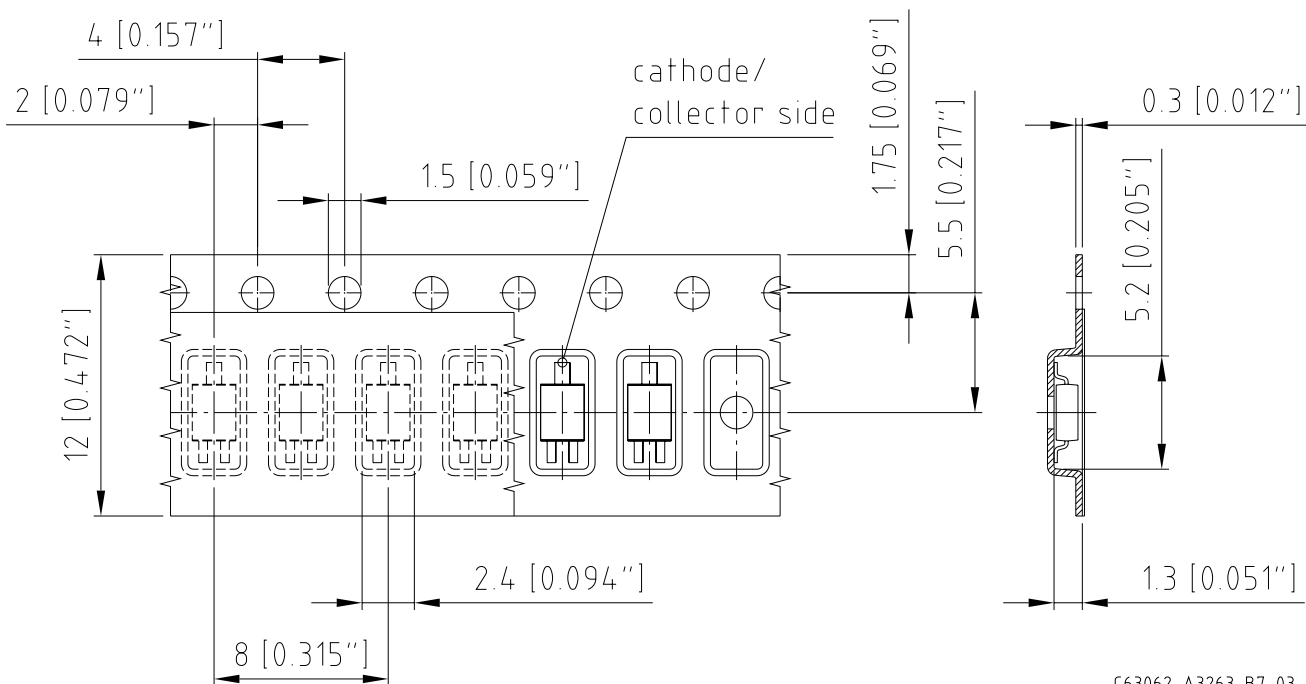

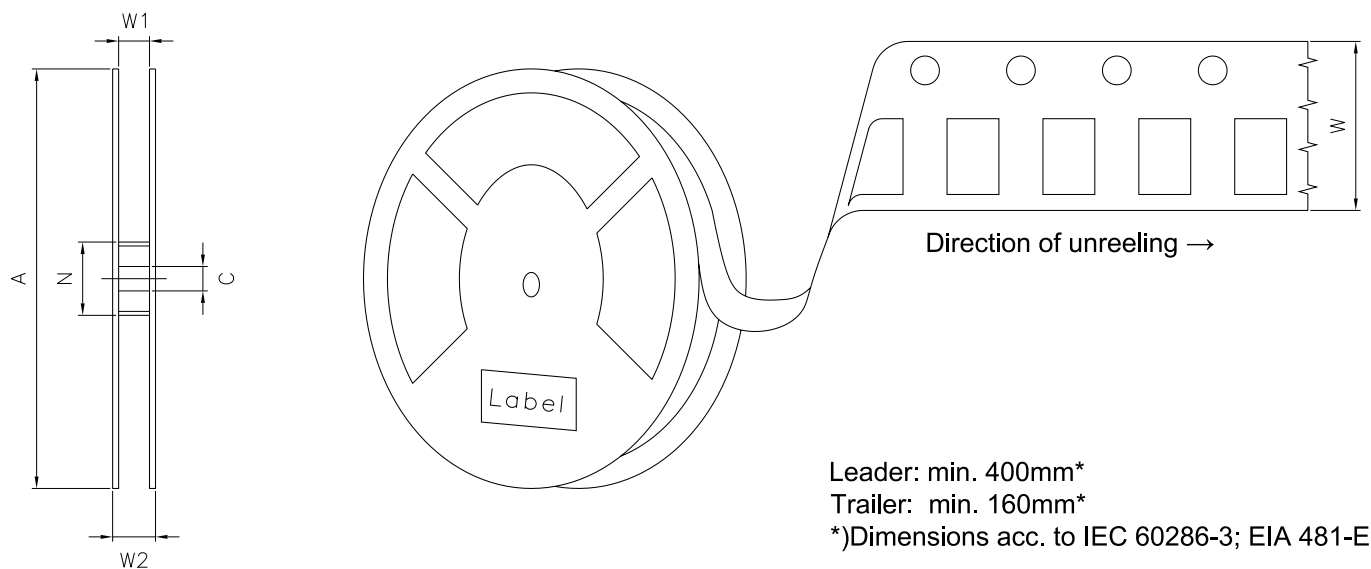

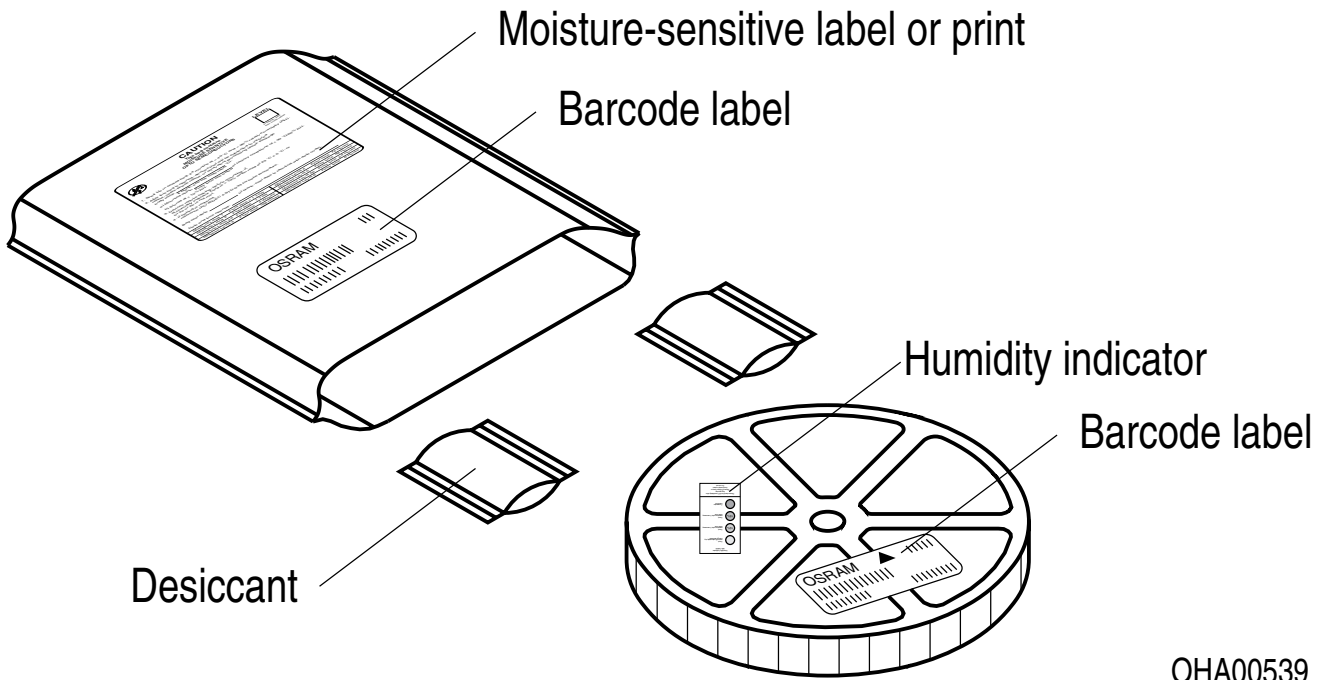

Notes
