SECTION 4: First aid measures

4.1. Description of first aid measures

If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Prevent formation of gases and vapours in flammable or explosive concentrations and concentrations exceeding the occupational exposure limits.
