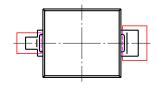









Component Location on Pad





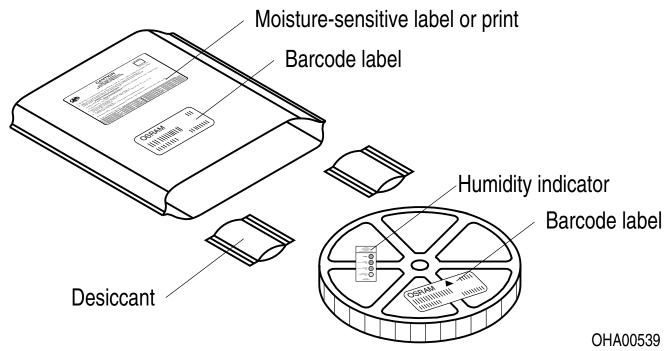

Notes
