


Fig. 1 - Power Dissipation Limit vs. Ambient Temperature




Fig. 2 - Collector Dark Current vs. Ambient Temperature




Fig. 3 - Relative Photo Current vs. Ambient Temperature




Fig. 4 - Photo Current vs. Collector Emitter Voltage




Fig. 5 - Photo Current vs. Illuminance




Fig. 6 - Collector Emitter Capacitance vs. Collector Emitter Voltage





Fig. 7 - Relative Spectral Sensitivity vs. Wavelength






